I. Call to regular meeting to order:

A. New Business:

1. 2020 Accident Insurance for Volunteers Program Renewal

There was a discussion on the value to Chelsea in purchasing accident insurance for the volunteers serving on various boards and committees. The coverage is an added incentive for residents to help serve. No action to purchase the insurance will be taken until the meeting when annual appointments are made.

2. Chelsea Public Event Planning Input

The Selectboard reviewed an event planning document prepared by Taylor Houdlette, Chelsea Summer Intern. The document outlines several events that Chelsea could sponsor to promote community spirit. The Selectboard were excited to have the document and will review it prior to the next meeting. The possibility of holding an event will be more thoroughly discussed.

B. Old Business:

1. Prepare for Town Meeting

The Manager and the Selectboard discussed the Town Meeting agenda, various articles of significance and assigned duties. No action was at taken.

2. CMP Transmission Line and Sub Station Valuation

The Selectboard/ Board of Assessors had requested the Assessors Agent review the current CMP values and the possibility of aligning the values with neighboring towns with similar transmission line and sub stations. The review was not ready currently. No action was taken.

3. Status Update and discuss the purchase of Chelsea Market

Not all members of the Selectboard have had an opportunity to inspect Chelsea Market. Selectboard members agreed to make this a priority so that a decision could be made on how to proceed. No action was taken.

4. 1989 Kenworth Fire Tanker disposition

The Town has received a bid of \$3500 on the 1989 KW Fire Tanker. The Selectboard did not take any action on this. Instead they agreed to defer the decision to dispose of the vehicle to a Procurement Officer.

The Selectboard requested the Town Manager prepare an amendment to the traffic control ordinance which would allow the Road Commissioner to close McLaughlin Circle at certain times of the year when the road is vulnerable to damage.
