A. New Business:

1. KVCOG Ballot for Election of Officers and Directors

The Manager reviewed with the Selectboard the proposed slate of membership to the KVCOG Board of Directors.

A motion was made by Sanderson that was seconded by Pushard to authorize the Town Manager to complete the ballot and vote on behalf of the Selectboard. The vote was unanimous of those present and voting.

B. **Old Business:**

1. Placement of a bench at Chelsea Heights Cemetery by Chelsea Historical Society.

There was substantial discussion on the matter of placing a bench in memory of Tom winter in the Chelsea Heights Cemetery.

A motion was made by Pushard that was seconded by Truman to table this matter until a future meeting

2. Approve demolishing house and cleaning up property a 330 Togus Road

The Manager reported that he had been the tax acquired property building to evaluate the condition. He also reported that he had spoken with Real Estate Agent Tony Lioko for his input on the value of the building.

A motion was made by Pushard that was seconded by Truman to authorize the Town Manager to work with a demolition contractor to tear the structures down and clean up the property. The vote was unanimous of those present and voting.

3. Town Space Needs Feasibility Study RFQ

The Manager discussed with the Selectboard the need for a review future town office needs in order to determine how best to proceed with either expansion or new construction. The Manager proposed sending out an RFQ to firms that perform Feasibility Studies. A motion was made by Pushard that was seconded by Truman to authorize the Manager to send out requests for qualification to firms that perform design services for a town space needs and feasibility study.
